### Recalls

Three cocoa products that were packaged and sold for Christmas are now being recalled due to possible contamination of an industrial chemical called melamine.

The products, G&J were sold nation wide by Shopko and Big Lots.

These products include G&J hot cocoa stuffer, G&J his and her hot cocoa set and G&J cocoa in French Vanilla.

There has been no reports of illnesses with this product, but samples taken have come back with positive results of melamine. If you have this product, you are advised to return it to the store of purchase for your refund.

**Note from the desk of Barb Tonkin**

**All U S D A pantries must have their monthly service reports turned in by their scheduled date.**

Kentucky commodity agencies monthly service reports are due by the 5th of every month. Indiana commodity agencies are due by the 5th of every month. Illinois commodity agencies invoices are due by the 15th of each month

All other agencies must have their monthly service reports turned in by the 15th.

If you only Gift in Kind shop, you are also required to turn in monthly service reports by the 15th of each month.
