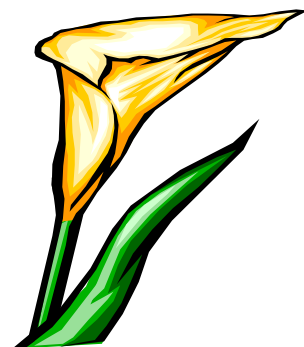

**A REMINDER OF WAREHOUSE RULES**

Only 1 agency in the shopping area of the warehouse at a time.

All Agencies must report to office before you are allowed in warehouse.

All agencies must come at appointed times.

There will be absolutely no product added to anyone's order. All items that can and will be offered through the warehouse, at your time of pick up, will be listed on the erase board.

Please understand we are enforcing these rules so no one will get hurt in the warehouse or the parking lot.

**MONTHLY SERVICE & REPORTS**

Monthly service reports are due here on or before your scheduled due dates. We are having a small issue getting our monthly service reports here on time. Please remember, Barb must have this on or before the due date.

Illinois USDA agencies must be here by the 15th. We must have all original signature sheets. No faxed copies will be accepted. All other agencies must also have theirs here by 15th.

Kentucky USDA agencies must have their monthly service reports in by the 5th of each month. Inventory sheets must be also turned in.

Indiana USDA agencies must submit their monthly service reports by the 5th of each month.

All other agencies must submit their monthly service reports by the 15th of each month. This is a part of your contract with the Tri State Food Bank.



**Easy Chicken Enchiladas**

- 3-cups cheddar cheese
- 1-4oz can chopped green chilies
- 2 cups of shredded Monterey Jack Cheese
- 2 tb Chopped onion
- 2 cups chopped chicken
- 1/4 tsp Pepper 1/8 tsp salt
- 2 cups sour cream
- 1 can cream of chicken soup
- 10-8in flour tortillas, warmed

In a large bowl, combine 2 cups of cheddar cheese, Monterey Jack Cheese, chicken sour cream, soups, chilies, onion, pepper, & salt. Spoon about 1/2 cup on center of each tortilla, roll up and place seam side down in greased 13inx9in baking dish. Cover and bake at 350 for 20 min. Uncover, sprinkle with remaining cheddar cheese. Bake 5 min. or until cheese is melted. Let stand for 10 min. before serving.

Recall Notices and Lists

The Tri State Food Bank realizes that the agencies are having a lot of questions concerning items that are on the peanut butter recall list. We are trying to update as soon as we receive word on what items need to be pulled. These are not coming as regularly as before, but we are still receiving them. Peanut Butter in Jars have **NOT BEEN** on the recall list. A lot of items such as cookies, cereal, brownie mix are on the recall notices. The list is long. Please go thru and read all of the recalls. We have made sure there are not any of the recall items are in our warehouse. Please make sure your pantry doesn't include any recall items.

Please check your order carefully when you receive it . You have 48 hours to notify us of any mistakes that we may have made. Yes we do, and will make mistakes. Please do not wait until your next appointment or when you receive your statement. It is easier for us to verify in the first 48 hours then it is in a month.
